# PRESIDENT'S MESSAGE

For some of us, this means weathering a storm or two as change occurs rapidly and unpredictably. For all of us, however, there is a promise of a brighter future for our students, one in which their roles as health care professionals are valued as never before.

In other news, AFPC and the Association of Deans of Pharmacy of Canada (ADPC) are partner organizations in the CPhA led Pharmacy Human Resources Study that was recently funded Foreign HRSDC and the Credential Recognition Program. The management committee has been meeting on a regular basis and a full Advisory/Management meeting is planned for April 10-11. Zubin Austin (AFPC) and Dean Dennis Gorecki (ADPC) are the official management committee representatives.

At the AFPC midyear meeting in Toronto on February 4-5, 2006 it was decided to fund a third

meeting of the SPEP coordinators group now called Pharmacy Experiential Programs (PEP) Canada. The meeting is scheduled to take place in Edmonton on June 1-2 just prior to the start of the Annual Conference. Representatives from key pharmacy stakeholder organizations will also be invited to attend. A strategic plan for the organization is to be completed and approved. The group will focus on developing standardized guidelines for PEP activities in Canada and work to create a national resource center that could be used to disseminate and share PEP resources. The intent of the activities is to enhance PEP nationally through a strong collaborative network.

## **Research Corner**

The Canadian Institute of Health Research (CIHR) has recently released two casebooks in the area of knowledge translation: Evidence in Action, Acting on Evidence http://www.cihrirsc.gc.ca/e/29489.html, CIHR Institute of Health Services and Policy Research, and Moving Population and Public Health Knowledge into http://www.cihr-irsc.gc.ca/e/29489.html, Action CIHR Institute of Population and Public Health. These online publications contain a collection of cases which demonstrate how research evidence gets used in strengthening Canada's health care system and improving the health of Canadians.

Drs. **Kishor M. Wasan** and **Ellen K. Wasan** have received a new Canadian Institutes of Health Research (CIHR) Operating Grant for \$282,567 over 3 years (April 1st 2006 to March 31st 2009) for their project entitled, "Intestinal Lymphatic transport of water-insoluble drugs."

**Dr. Kishor Wasan**, J. Frohlich, J. Hill and K. Sachs-Barrable have received a three year CIHR grant for the project entitled, "The role of serum lipoproteins in optimizing amphotericin B therapy", in the amount of \$290,526.

**Drs Kishor Wasan and Ric Procyshyn** have received funding in the amount of \$26,000 from the Riverview Hospital Research Foundation for the project entitled "Investigating Risperidone's Influence on Clozapine's Plasma Protein and Lipoprotein Distribution."

As the co-PI on a recently awarded NSERC Research Tools and Instruments grant, **Dr. Urs Hafeli** will have free access to the micro Particle Image Velocimetry (PIV) system acquired with the grant funds (\$106,182). Boris Stoeber from the MEMS and Nanotechnology Department in Mechanical Engineering is the PI on the grant. A microPIV system allows for the observation of the movement of microparticles in flow channels and

under the influence of external forces such as magnetic fields. The microPIV system will be connected to a new fluorescent microscope.

**Dr. Sylvia Ng** has received a TFF Research Grant for New Investigators entitled, "the role of cancer associated fibroblasts in mediating treatment response in pancreatic cancer". It is a three year grant from 2006-2009 in the amount of \$145,622 per annum. Dr. Ng also received a one year TFF equipment grant in the amount of \$37,915.

CIHR has awarded a five-year grant in the amount of \$820,000 to Dr. Jean Shoveller (PI: UBC HCEP), **Dr. Judith Soon** and multidisciplinary co-investigators from UBC Nursing, University of Northern BC, BC Centre for Disease Control, Queen's University and Dalhousie University. # TAKING NOTE

## **CPHA REPORT**



Dear Colleagues,

CPhA's Board of Directors met March 3-4, 2006 in Ottawa. This newsletter will report on the meeting and recent CPhA activities.

# **Financial Update**

At its February meeting, the Board reviewed the previous year's financial statements and approved the budget for the year ahead. Financial results for 2005 showed a year-end surplus close to \$697,028. This surplus will be reinvested in business development funds to work on e-publications and the website, building maintenance and CPhA's 2007 Centennial.

A celebration is in order with the mortgage on CPhA's building to be fully paid in 2006. However, with any 20 year-old building, ongoing maintenance is necessary. A plan has been adopted for major structural work to begin this year. Renovations to the office space were completed in 2004.

#### e-Business

The 2006 budget focuses on the need to develop revenue from the sale of digital products. e-Therapeutics is now available for purchase at a cost of \$225 per year for a single user licence. e-Therapeutics<sup>+</sup>, which includes the

full e-CPS application, costs \$389 per year per single user licence. CPhA membership will provide a 25% discount. e-Therapeutics<sup>+</sup> includes all functionality through one access point and the bonus of a handheld companion providing selected drug information.

e-Therapeutics, funded from Health Canada's Primary Health Care Transition Fund until June 2006, provides point-of-care access to current, evidence-based Canadian drug and therapeutic information for primary health care practitioners. To help provide oversight of the financial risks related to the development and marketing of CPhA's digital products and to provide guidance on business strategy, the Board has established an e-Business Review Committee. Membership will include Board members, the Chair of the Audit Review Committee and one or two external members with expertise in information technology and the health care environment.

## **Blueprint for Pharmacy**

Changes in the pharmacy profession are essential to achieving health care reforms, particularly with enhanced roles for pharmacists in primary health care. Although substantial resources have been committed by governments to health care renewal, and various projects and programs are now underway to assist in moving the profession forward, the profession has been lacking an overall high-level plan to guide and coordinate action over the next five to ten years.

In recognition of this, CPhA facilitated a workshop in Ottawa, December 2-3, 2005, for a small group of 25 pharmacists and leaders from across Canada to develop

a Blueprint for Action for the Pharmacy Profession. The Blueprint will identify structural, legislative, policy, program and funding requirements to support change in the pharmacy profession and will identify actions over the next five to ten years necessary to move the profession forward. Elements include: role change and pharmacy practice models: pharmacy human resources: pharmacy education and continuing professional development; information and communications technology; financial viability and sustainability: legislation, regulation and liability; and leadership for the profession.

A background paper prepared for the December workshop, which outlines where the pharmacy profession is today and where it must go in the future, has been updated to include deliberations from the workshop. A meeting is being planned for May or June 2006 when this draft will be shared with all pharmacy stakeholders for their input on the elements being addressed, actions to be taken and priorities. This will be followed by consultation with other stakeholders in health care and governments, hopefully leading to widespread endorsement.

# **CPhA** and **Provincial Pharmacy Voluntary Organizations**

The Board approved principles developed at a February meeting with the Executive Directors and Chief Executive Officers of CPhA and provincial pharmacy voluntary organizations to build better working relations. It was agreed to establish a new forum, to be called the Canadian Pharmacists Affairs Group, through which consultation and working together on key priorities can take place on a regular basis.

## **Term of Office**

The Board has requested the Association Affairs Committee to prepare amendments to the Bylaws and Regulations to change the term of office for Board members representing a constituency, except for Students and New Practitioners, to three years, because of the learning curve for new members. Also, amendments to the Regulations have been requested so that two Board members elected from the same province, i.e. Ontario, will be elected in different years. Bylaw amendments will be presented to the Annual General Meeting June 4, 2006 in Edmonton.
