## **EXECUTIVE DIRECTOR'S CORNER**

The following is a report on Executive Director, and AFPC and ADPC activities.

#### **Executive Director Activities**

My summer was a busy one. A significant amount of my time was dedicated to the Canada Health Infoway Clinicians in Training funding proposal. This required a significant amount of front end work: fine tuning the proposal, the development of a formal written agreement with CHI, and the hiring of a project manager. In July, I attended the 2011 Annual American Association of Colleges of Pharmacy conference in San Antonio. The conference is extremely valuable in networking with people and learning about the activities that AACP engages in. In relation to further planning with regard to our new governance model, I attended some workshops on a new piece of federal legislation "Canada's Not-for-profit Corporations Act". The directions being considered in our new governance model appear to be in alignment with this new legislation.

#### **AFPC and ADPC Activities**

## AFPC Council

Ingrid Price (University of British Columbia) began her Presidency at the AGM. Daniel Thirion (University of Montreal) became the President Elect. AFPC councilors either renewed or elected in 2011 were: Andrea Cameron (University of Toronto), Carla Dillon (Memorial University), and Kerry Mansell (University of Saskatchewan). Congratulations to these Executive and Councilors.

The following were some of the agenda items addressed at the June 2011 AFPC Council meetings: individual committee reports, identification of 2012 council priorities, 2012 committee appointments, council feedback to CCAPP revised standards, levels of performance for educational outcomes, and specialized pharmacy residencies. External stakeholder consultation occurred with ISMP about medication safety. The levels of performance for the educational outcomes has been posted on the AFPC website.

### ADPC (Deans)

There have been three new Deans appointed in 2011 to lead Canadian pharmacy faculties: Dr. Neal Davies at the University of Manitoba, Dr. David Edwards at the University of Waterloo and Dr. Jean Lefevbre at Laval University.

ADPC held meetings in Winnipeg (June 6 interim) and Mont Tremblant (October 2,3 annual). The following are samples of items being reviewed at the Deans'

meetings: rapidly changing pharmacy manpower situation, and Blueprint for pharmacy commitments. The Deans routinely consult at their meetings with external stakeholders e.g., at the October 2011 meeting consultation occurred individually with representatives of Canadian Medical Association, Canadian Pharmaceutical Association and Canadian Generic Pharmaceutical Association

### New Governance Model

The new AFPC governance model was presented at the 2011 Annual General Meeting. There appeared to be widespread general support for the new model. One area was identified for further study. A new piece of federal legislation has been introduced "Canada's Notfor-profit Corporations Act". This legislation is anticipated to come into effect in fall 2011 and will affect approximately 19,000 national not-for-profit organizations (including AFPC). The legislation expands and clarifies member rights and clarifies duties, powers, potential liabilities and the standard of care for directors. The sessions helped to understand the Act and the forthcoming regulations.

## <u>CPERC</u>

Attendance was approximately 120 and feedback was positive about the conference program content and format. The conference was a financial success with there being an excess of revenue over expense. Once again, special thanks to Silvia Alessi-Severini (conference chair), Lavern Vercaigne (acting Dean) and the members of the planning committee for their hard work in making the conference a success.

# <u>Canada Health Infoway (CHI) - Pharmacists in Training grant</u>

In July we were pleased to hear that our AFPC proposal was approved to establish a national education program on information and information technology for pharmacists in training. The project is entitled "Educational Program for Optimizing the Use of Pharmacy Information and Information Technology". The project will allow AFPC to develop and host a national education program for pharmacy teaching programs and students. The project is a huge opportunity for AFPC. The course will be designed so that it can be integrated into educational curricula. A formal written agreement has been established between AFPC and CHI. # <u>Liaison with Annual American Association of Colleges</u> of Pharmacy (AACP)

Lalitha Raman-Wilms and I attended the July 2011 by t Annual AACP conference in San Antonio. Lalitha Ann provided an official greeting from AFPC. We were able

to communicate directly with Lucinda Maine and other individuals either working for the organization or in elected positions. AACP has many experiences, programs and services that AFPC learn about. The educational sessions were valuable in that I was able to learn about various innovative pharmacy education programs and services being offered in US universities. The trade show was valuable as I was able to make contact with vendors providing student software tracking programs and security check firms.

### Blueprint for Pharmacy

The Blueprint for pharmacy national office is in the process of fundraising. One of the major activities where AFPC is a lead organization is for the action objective relating to experiential education. The action objective is as follows: increase the accessibility, quality, quantity and variety of experiential learning opportunities to prepare pharmacy professionals, including students, to practice in expanded and innovative roles. PEP-C has been active in developing a project charter to initiate the action objective by holding a multi step, multi stakeholder, facilitated workshop on developing future models and strategies for experiential education. The proposal was developed by the PEP-C chair, Andrea Cameron and vice chair, Ann Thompson.

## FACULTY SPOTLIGHT: UNIVERSITY OF TORONTO

#### **Curriculum News**

The 2011-2012 academic term marks a transformative moment in the history of the Leslie Dan Faculty of Pharmacy at the University of Toronto. This September, the Faculty began delivering our new undergraduate curriculum, and ushered in the first group of students to participate in a new program - the Combined Bachelor of Science in Pharmacy-Doctor of Pharmacy program.

Led by Associate Professor and Interim Associate Dean, Professional Programs, Lalitha Raman-Wilms, the new curriculum features several substantial changes over the previous curriculum including moving several courses into prerequisites, increasing the number of pharmacotherapeutics courses, integrating medication therapy management into the curriculum, and incorporating greater experiential components into the program beginning in first year. The new curriculum directly addresses the changing scope of pharmacy practice in Canada, while including elements that will further shape and define the profession in the future.

At the same time, the Faculty introduced a new program that joins the Bachelor of Science in Pharmacy degree with the Doctor of Pharmacy degree to create a Combined Bachelor of Science in Pharmacy-Doctor of Pharmacy degree. Open to students entering the 4th year of the BScPhm program at the Faculty, this

program provides students with an opportunity to continue their education and begin working on a second, advanced degree concurrently with the undergraduate program course requirements.

A total of 31 students are now participating in the inaugural year of the combined program where they are taking Doctor of Pharmacy courses in addition to the regular undergraduate courseload. Beginning in January, they will participate in an introductory experiential rotation before returning to the classroom for additional Doctor of Pharmacy courses. From that point on, the program rotates between coursework and experiential placements until May 2013. Once this additional year of courses and specialized placements is complete, participants will graduate with two degrees.

The Combined Bachelor of Science in Pharmacy-Doctor of Pharmacy program combines two of the Faculty's most successful degrees into a single program that equips students with the skills, knowledge, and experience required to excel as advanced practitioners.

#### **Funding & Research News**

This Spring, the Faculty announced a \$1 million donation from Walmart Canada to establish the Walmart Canada International Pharmacy Education Centre. This Centre includes a one hundred seat classroom and student break-out areas equipped with state of the art video-conferencing and audio visual equipment designed to enhance and expand the International Pharmacy Graduate (IPG) program.



The IPG program provides internationally-educated pharmacists with the knowledge and skills necessary to meet Canadian pharmacy practice standards and licensing requirements. Since 2000, close to 800 students have completed the program, which has established itself as a model in bridging education. Offered twice a year with enrolment of over 75 students in each intake, this commitment from Walmart Canada will facilitate an anticipated 30 per cent increase in enrolment over the next several years. This increase will make a significant difference in meeting the growing demand in Canada for qualified pharmacists.

Walmart Canada's generous donation provides the funding and physical infrastructure to increase enrolment, augment program offerings, and enhance the overall learning experience. It will provide students with a designated space to study, attend classes, and interact with faculty, staff and pharmacy practitioners to develop the skills and support networks necessary to succeed in Canadian pharmacy practice.

Professor **David Hampson** recently received a fouryear operating grant under the CIHR Industry-Partnered Collaborative Research grants program. "Metabotropic Glutamate and GABA Receptors in Neuroinflammation" will investigate the notion that several neurological and neuropsychiatric disorders including schizophrenia and autism spectrum disorders are associated with an immune reaction in the brain and the evidence that metabotropic glutamate and adenosine neurotransmitter receptors might be involved in, or able to modify this immune response in this central nervous system.

Professor **K. Sandy Pang** recently received a four-year CIHR operating grant as the Principal Investigator on "A Role for the Vitamin D Receptor (VDR) in Cholesterol Lowering." The grant is shared with Co-Investigators, Drs. **Carolyn Cummins** and **Lakshmi Kotra**. Dr. Pang has been working in the area of the VDR for the past five to six years and found that the VDR, when activated by the active ligand,  $1\alpha,25$ -dihydroxyvitamin D3, manifests inductive or inhibitory effects on transporters and enzymes, including induction of cholesterol 7a-hydroxylase (CYP7A1) that led to cholesterol lowering in mice fed a high fat/high cholesterol diet.

Professor and GlaxoSmithKline Chair in Drug Delivery Ping Lee also received a three-year grant from CIHR for "Nitric Oxide Delivery System for Wound Healing." Diabetic foot ulcers are a leading cause of amputations in diabetes patients, and an effective therapy for treating chronic diabetic foot ulcers is still lacking. Nitric oxide (NO), a critical mediator in normal tissue repair, has been shown to play a pivotal role in the overall wound healing process. Dr. Lee has developed a simple, stable and biocompatible system that can release NO over an extended period of time. The results obtained from this study will help the design of more effective NO delivery systems for enhancing diabetic wound healing and should have a significant impact on the health care system by reducing the need for amputations in millions of diabetic ulcer patients.

Professor **Shana Kelley** is the recipient of an Ontario Research Fund - Research Excellence award. The Ontario Research Fund Research Excellence program

supports transformative, internationally significant research, and targets new, leading-edge research initiatives. "Nano-enabled devices for disease prevention and control" will see the development of a device for the capture of prostate cancer tumor cells to enable early cancer detection. This device will utilize sensitive nanomaterials developed in Dr. Kelley's lab to allow the cells to be pulled out of blood samples, including the low levels of molecules that can be the early signs of disease.

Professor **Peter Wells** is the recipient of a five-year grant from Canadian Institutes of Health Research for "Free radical determinants of neurodegenerative disease." For this project, Dr. Wells and his team will examine the neurodegenerative role of reactive oxygen species (formed during normal body metabolism of amphetamine and related drugs, which are widely prescribed to children with attention deficit-hyperactivity disorder), and the protective pathways that detoxify ROS or repair the brain damage.

This summer, a group of students from the Faculty had the opportunity to participate in a large scale research project at the Ontario Science Centre. Dr. Anna Taddio enlisted students from across the Faculty on this project, spending six days a week over the course of the summer questioning over 2,000 parents and children about needle fear and immunizations. This unique opportunity to partner with one of the world's leading interactive science museums provided Dr. Taddio and her team with an excellent chance to learn more about the factors that influence parents' decisions to immunize their children. Ultimately, Dr. Taddio hopes to use these findings to demonstrate how effective pain management practices would impact immunization compliance.

### **Faculty News**



Assistant Professor Muhammad Mamdani was named one of Canada's Top 40 Under 40 by The Globe and Mail As pharmacoepidemiologist and Director of the Applied Health Research Centre at St. Michael's Hospital, Mamdani helps policymakers evaluate the risks and costs of drugs, and has been able to

carve a niche for his research by drawing together several disciplines - a Doctor of Pharmacy degree from the University of Michigan, a Master's degree in Public Health (Biostatistics and Epidemiology) from Harvard, and a Master's degree in Economics from Wayne State University. This varied academic background allows him to access health care databases to examine the effects of different drugs on patients' health and how resources are used, allowing for better decisions about health care delivery.

After six years leading the Graduate Department of

Pharmaceutical Sciences, Dr. Reina Bendayan stepped down as Associate Dean, Graduate Education, effective June 30th. As the recent recipient of a Career Scientist Award from the Ontario HIV Treatment Network, Ontario Ministry of Health, Professor Bendayan leaves her role as Associate Dean to focus on her research in the field of antiretroviral drug



transport at blood-tissue barriers. Since 2005, Dr. Bendayan has led the graduate department and has been instrumental in directing its expansion and attracting the top graduate students to the Faculty's MSc and PhD programs.

Dr. **Heather Boon** was recently appointed Associate Dean, Graduate Education. Dr. Boon brings a great deal of experience and insight to this role - during the 2010-2011 academic term, Dr. Boon was the Interim Associate Dean, Graduate Education. Prior to that, she served as the Department's Graduate Coordinator.



In July, Dr. Lakshmi Kotra joined the Faculty as a full-time tenured Associate Professor. Dr. Kotra takes on this appointment in addition to his roles as Director of the Centre for Molecular Design and Preformulations at the University Health Network, and Scientific Director for UHN-Shanghai, Inc. Dr. Kotra's research applies an integrated approach in drug discovery combining advanced principles/technologies in chemical biology, target information, computer

modeling, medicinal chemistry and biochemistry principles for efficient drug design process to generate lead compounds for development as therapeutic agents.

The Faculty has created six new jointly-funded positions with Toronto-based health institutions – four Clinician Scientists and two Clinician Educators.

Dr. Carlo DeAngelis has been appointed to the position of Assistant Professor and Clinical Scientist at Sunnybrook Health Sciences Centre. Dr. DeAngelis

will focus on clinical research in oncology. In this role, he continue to provide leadership and mentorship for scholarly activity practitioners. pharmacy residents and fellows at Sunnybrook as well as fulfilling teaching responsibilities through the Division of Pharmacy Practice.



Dr. Marisa Battistella has been appointed to the position of Assistant Professor and Pharmacy Clinician Scientist at University Health Network (UHN). In her



new role within the Division of Pharmacy Practice, Dr. Battistella's primary focus will be clinical research with expectations to develop and build a self-sustaining clinical/translational research program in affiliation with

our Faculty and UHN. She will continue to provide leadership and mentorship for scholarly activity to practitioners, pharmacy residents and fellows, and will also continue teaching in the professional pharmacy curriculum. Dr. Battistella's main practice, teaching and research area has been in hemodialysis/nephrology at the Toronto General Hospital.

Dr. Beth Sproule has been appointed to the position of Assistant Professor and Pharmacy Clinician Scientist/ Advanced Practice Pharmacist at the Centre for Addiction & Mental Health (CAMH). Dr. Sproule has taught for many years at the Faculty within the graduate, undergraduate and Doctor of Pharmacy programs.

Dr. **Natalie Crown** joined the Faculty this summer as a Clinician Educator and Assistant Professor through a joint appointment with Women's College Hospital (WCH). Dr. Crown is a graduate of the Pharmacy Program at Dalhousie University and the Doctor of Pharmacy program at the University of Toronto. Prior to accepting this joint position, Dr. Crown was a



clinical pharmacist in the Atrial Fibrillation/Anticoagulation clinic and Residency Coordinator at the London Health Sciences Centre, where she also held the position of Adjunct Assistant Professor, Division of Clinical Pharmacology, Schulich School of Medicine and Dentistry, at the University of Western Ontario. Since starting her

new position, Dr. Crown has been involved as a Cocoordinator for several Doctor of Pharmacy courses, spearheaded the development of a hospital Ambulatory Care Pharmacy Practice Residency, and coordinated experiential learning placements at WCH. Dr. Lisa McCarthy was appointed an Assistant Professor and Clinician Scientist within the Division of Pharmacy Practice at the Faculty this summer. A graduate of the Faculty's Bachelor of Science in Pharmacy and Doctor of Pharmacy programs, Dr. McCarthy has held a status-only appointment with the Faculty since 2007, coordinated Physical Assessment for the Doctor of Pharmacy program and instructed in the 4th year undergraduate Women's Health elective. In addition to her teaching responsibilities at the Faculty, Dr. McCarthy will be responsible for

developing a clinical practice with the Complex Care Clinic of the Centre for Ambulatory Care Education at Women's College Hospital. Her research will focus on optimizing safe medication use in ambulatory care as well as models of pharmacy practice in the ambulatory care setting.



Marie Rocchi was appointed Director of Educational Programs at the Centre for the Evaluation of Health Professionals Educated Abroad, an Ontario-based organization with a focus on physicians and nurses. In this position, Marie is responsible for the design, implementation and evaluation of a pre-residency online training program for medical residents about to undertake specialty or Family Medicine residencies in Ontario. Marie also continues her teaching commitments at the Faculty.

## **Strategic Planning**

Throughout 2011, the Faculty has been preparing a strategic plan. As part of this process, faculty, staff, students, and members of the pharmacy community met at a retreat to discuss the Faculty's strategic plan. Facilitated by Dean Emeritus Wayne Hindmarsh and Bystrin, Director of the Continuous Maria Professional Development program, the day featured presentations and lively discussions about the Faculty, potential goals and objectives, and the steps that need to be taken to achieve these goals and meet these objectives. Throughout the summer, the feedback and input provided at this session have been incorporated into the development of a strategic plan for the Faculty that will outline our goals and aspirations for the next five years.

# **Outreach News**

During the summer, the University of Toronto runs a 4-week program that provides high school students of Aboriginal and African ancestry (groups that have not traditionally participated in health care professional education) with an opportunity to explore post-secondary programs in the health sciences. Second year pharmacy student **Ida Famiyeh**, a graduate from and a coordinator of this program, led the Faculty initiative.



After learning about the many exciting opportunities that exist for pharmacy grads, the group was treated to several pharmacy-related activities – making sense of prescriptions, checking prescriptions for errors using the Compendium of Pharmaceutical Specialties, and making suppositories, slime, and tablets in the lab. The event was a tremendous success - the students enjoyed their time at the Faculty, and left with a greater understanding of and appreciation for pharmacy and pharmaceutical sciences.

Each summer, students in the Faculty's Bachelor of Science in Pharmacy program apply the skills and knowledge they have acquired in the classroom in Summer Internship positions across the globe. Through these experiences, students are able to see how pharmacy is practiced in other countries, and measure what they learn here against what is happening in other parts of the world.



As part of the Faculty's Summer Internship Program, **Heather Bannerman** and **Priya Bansal** spent 10 weeks in Namibia at the Katutura Health Centre, where they worked in a facility that provides specialized services for HIV and tuber-culosis. In this role, they counseled patients, dispensed antiretroviral and tuberculosis medications to HIV patients, assessed patient adherence, and developed educational posters and videos that demonstrated the importance of medication adherence.



Third year student Sarah Bonazza interned the Good Governance for Medicines Programme Geneva, Switzerland, where she

performed an intensive global literature review, developed a background report, presented her findings to WHO staff and interns, and composed a journal article to educate others on these issues.

Maria Zhang participated in an internship program

with the Stop-**Tuberculosis** Partnership that was also housed at the World Health Organization in Geneva. Through this internship, Maria worked part of the Global Drug Facility, an organization that provides access



high quality tuberculosis medications, and has supplied more than 18 million patient treatments since it was established ten years ago.

#### **Educational Programming**

In July, the International Pharmacy Graduate (IPG) program began offering a hybrid online course to allow internationally-trained pharmacists greater access to the Faculty's IPG program.

Consisting of two 14-week learning modules, including three weeks of Toronto-based workshops, the IPG program offers pharmacists trained in other countries the opportunity to acquire the professional and clinical skills necessary to practice as a pharmacist in Canada. The expansion of the program to include an online offering is designed to provide students who live outside of Toronto, as well as those who may be working part-time, the opportunity to participate in a program that equips them with the knowledge and skills needed to succeed in Canadian practice. The expansion of the IPG program to include an online offering was made possible through the generous support of Walmart Canada.





School of Pharmacy releases 2010-2011 annual report: High demand for increased enrolment, extreme space shortages highlighted by Dean Hensman (Memorial University News Release – Sept 17. 2011 - <a href="http://on.fb.me/qJDEmu">http://on.fb.me/qJDEmu</a>) Copies of the report are available on the school's website: : www.mun.ca/pharmacy

The School of Pharmacy released its 2010-2011 annual report during the Pharmacists' Association of Newfoundland and Labrador's (PANL) annual conference held in St. John's. In addition to its annual overview of school, student and faculty achievements, the report highlighted the current challenge faced by the school to meet the high demand for increased enrolment coupled with an extreme space shortage.

Dean Linda Hensman addressed the province's pharmacy community at PANL's gala conference dinner, noting that "inadequate classroom, laboratory, office and gathering spaces restrain our capacity to enhance a teaching and learning environment that will meet the future pharmacy needs of the province."

Don Rowe, the secretary-registrar of the Newfoundland and Labrador Pharmacy Board (NLPB), agreed. "The future is always difficult to predict, particularly when it comes to an issue such as human resources requirements for the health professions, and even more so at this point in time when significant changes are occurring in the scope of practice of pharmacists... However, according to current registrations with the NLPB, 32 per cent – that's 215 – of the pharmacists in this province are at or near retirement age. With the current rates of enrolment at the School of Pharmacy, it worries me that it would take almost a decade to fill those vacancies, let alone allow for growth in the profession." "The demands on the provincial pharmacy community are growing," said Mary Ann Butt, PANL's executive director. "Everyone knows that the demographics are shifting towards an aging population," added PANL president Rick Elliott. "With this shift will come an increased demand for pharmacy services in our province – and our membership will be on the frontlines."

Dr. Hensman said that the prescription for this problem is one that no pharmacy can fill. "We are preparing for expansion right now as best we can...through the hiring of new faculty and staff, and by establishing a temporary off-site office location for our clinical faculty. We recognize that there is a shortage of space for academic units across the St. John's campus and are pleased that the ongoing space planning effort at the university includes additional space for the school. I am confident that we can achieve the twin goals of expansion of the school and sufficient permanent space in which to house it."

I am delighted to announce that our CAPSI teams consisted of more than 170 runners and our goal of \$20,000 raised was met! I am optimistic that next year we will be able to engage more faculties and raise further funds this worthy cause.

Looking forward, CAPSI's annual Professional Development Week (PDW) conference will be hosted by Dalhousie University from January 11<sup>th</sup> to the 15th, 2012. Here students will be introduced to the 'Oceans of Opportunity' that are available to them as our profession continues to move forward. With PDW around the corner, local CAPSI competitions are underway across the country. This year is particularly exciting with the new Evidence Based Practice competition being trialed at select pharmacy schools, with hopes of expansion next year. Other competitions include the Patient Interview Competition, Student Literacy Challenge, the OTC Competition and the Compounding Competition. These

competitions not only provide students with the chance to apply the skills learnt in the classroom to real world scenarios, but also the opportunity to win national accolades amongst their peers and colleagues.

I hope that I have successfully highlighted some of our recent successes and future goals. As always, your continued support of CAPSI and its student initiatives is greatly appreciated.
