PRESIDENT'S MESSAGE

Your association is undergoing a change to face future challenges. This year's main objective is to merge ADPC with AFPC into the single AFPC entity. This will allow for quicker decision-making, clarify resource allocation, and improve communication between all members. Deans and Faculty members will have the opportunity to contribute with equal representation on the Board of Directors. Independent matters concerning either Deans or Faculty members will be discussed within respective councils of AFPC. Another advantage of this merger is to provide a single clear voice of representation for pharmacy education and research in Canada. External stakeholders will be able to dialogue with this association understanding a distinct and unique mission.

The restructuring process should appear seamless, as efforts remain focused on main issues including experiential programs. As you know, graduating from a professional degree and stepping into practice is challenging. Students who initially work up case studies to treat patients on paper start working in practice settings of increasing responsibilities requiring numerous competencies. These competencies include leadership, interpersonal skills of communication, collaboration and management – just to name a few. AFPC strives to facilitate this transition, by setting the goal for students to be ready for practice. AFPC has made the Pharmacy Experiential Program (PEP) Canada a priority because experience as training is key for pharmacy students. This is actually well delineated

within CCAPP's (Canadian Council for Accreditation of Pharmacy Programs) new accreditation standards coming in January 2013, presenting the strong experiential component of pharmacy entry to practice programs. Resources are being invested in developing strategies that will benefit all Faculties with input from clinical decision makers directly involved in on-site training. I'm looking forward to results of these efforts in time for the next annual Canadian pharmacy Education and Research Conference (CPERC) meeting in June 2013 to be held in Niagara-on-the-Lake.

Last but not least, a word on technology. Have you noticed toddlers swiping the TV screen with their fingers trying to change channels? Amazing how technology has been adapted to a three-year-old's learning process. Students develop and adapt to technology faster than it can be integrated into education, research and practice. They are already implying that e-mail is now obsolete! So why are we, as an association, investing time and energy in developing the AFPC-Infoway Project? Because age is the most important factor that impacts technology use and integration. Technology is no different than all other worlds of learning. The older the practitioner, the less likely technology will be incorporated into his/her work, and even less likely to be adapted to the patient being treated. Our working group will address the issues of technology in professional practice to understand and plan how these aspects can become an organized component of our programs.

EXECUTIVE DIRECTOR'S CORNER

The summer is over. The fall academic term is well underway. Where did the time go?

Since my last report, the major activities were the successful staging of our 69th Annual Meeting and Conference (Canadian Pharmacy Education and Research Conference) in Quebec; attendance and participation in the 2012 AACP Conference; the

launching of the first annual AFPC pharmacy graduate employment survey; and the development of written information and communications technology competencies for pharmacy students.

The following is a report of selected Executive Director, Council of Faculties and Council of Deans activities.

Executive Director Activities

Governance model – The new bylaws were reviewed and approved by the Council, the Deans and at the Annual General Meeting. A final set of bylaws has been circulated to the Board of Directors, Council of Faculties and Council of Deans members for final review. A Certificate of continuance was obtained from Industry Canada to operate under the new federal not-for-profit act. The next step is to submit an application to Canada Revenue Agency to maintain charitable status under the new act. The new Board of Directors will meet via a teleconference in October (confirm President, vice president, approve interim operating budget for 2013, and discuss board policies e.g., faculty member guidelines).

<u>Financial reporting</u> – AFPC 2012 financial record keeping is occurring using Quickbooks. Ms. Doreen Sproule has entered AFPC income and expense data up to and including August 2012, and entries are being cross checked. An 8-month financial report will be prepared for reviewing financial performance for this

Council of Faculties / Council of Deans

Awards – The awards book has been revised for 2012-13 and will be posted on the AFPC website. We have not found external sponsorships for the New Investigator Research Award (previously sponsored by Sanofi) and the National Award for Excellence in Education (previously sponsored by Bristol-Myers-Squibb [BMS]). Under our current financial policy, AFPC will not progress with an award when funding is not available. A decision will be required about going ahead with the two awards. There will be a new award sponsored by PEBC, the "PEBC AFPC Award for Research and Innovations in the Assessment of Competence". Details about the PEBC award will be available on the AFPC web site.

<u>Council 2012 Annual Meeting</u> – The council annual meeting was held in 2 parts (May 23 conference call,

Oversight activities – Over the summer, the majority of my time has been spent on book keeping and paying for expenses associated with 2012 CPERC, and where required monitoring and providing leadership for experiential education workshop and the Pharmacists in Training project.

AACP conference – Dan Thirion and I attended the 2012 American Association of Colleges of pharmacy (AACP) meeting in Kissimmee Florida. There were nearly 2000 attendees. As in other years there were a large variety of topics addressed. My focus was to attend educational sessions on health informatics and international projects, and AACP business sessions. Contacts were made with representatives from the European Association of Faculties of Pharmacy and with the Pan American pharmacy group.

June 5 face to face meeting). Daniel Thirion was elected the new President. The new AFPC bylaws were reviewed and approved. Under the new structure, the Council of Faculties will have a Chair and Vice Chair. Also, five Councilors were appointed to the new Board of Directors: Daniel Thirion (Montreal), Kerry Mansell (Saskatchewan), Silvia Alessi-Severini (Manitoba), Nancy Waite (Waterloo), and Carla Dillon (Memorial).

<u>Deans 2012 Interim meeting</u> – The Deans interim meeting was held on June 6. The new bylaws were reviewed and approved. Under the new structure, the Council of Deans will have a Chair and Vice Chair. Five Deans were appointed to the new Board of Directors: Robert Sindelar (British Columbia), James Kehrer (Alberta), Henry Mann (Toronto), Jean Lefebvre (Laval), and Rita Caldwell (Dalhousie).

<u>CPERC 2012</u> – The number of registrants for the Quebec conference was 116. There were 13 speakers and panelists. Feedback received about the conference was very positive about the content and format. From a financial standpoint, there was a surplus of revenue over expenses. Copies of presentations and slides are available through Council of Faculty members who have access to them on Dropbox link. If you are interested in receiving slides, please contact your Councilor. Thank you to Frederic Calon, Jean Lefebvre, Claude Massicotte, and Eric Couture.

Education committee – Eric Schneider (Waterloo) has accepted the role as chair of the Education committee. Nancy Waite and Cynthia Richards are the co-chairs for the 2013 CPERC planning subcommittee. We are looking for volunteers to assist in the planning for CPERC 2013 (please contact the Executive Director hlopatka@telus.net if you are interested in assisting).

<u>Educational outcomes</u> – The 2010 educational outcomes are now translated into French. They have been posted on the AFPC website under News and Publications (Publications).

Experiential education workshop – The workshop is held on October 17 with approximately 25 individuals to attendance. A planning group was set up (Ann Thompson, Andrea Cameron, Angela Kim-Sing and Harold Lopatka) and the group continued over the summer with the facilitator (Art Whetstone) to fine tune the agenda and review the participant preworkshop survey. Participants receive a pre-workshop survey and will be provided with background readings. A report will be prepared by the facilitator and be available for review at the mid year meetings. The purpose of the workshop is to develop consensus about concepts / principles relating to experiential education, and to enable a national strategy / plan to be developed to improve the quality and capacity of pharmacy experiential education in Canada. The workshop topic is very timely as an overview of hospital experiential education was recently published in the Canadian Journal of Hospital Pharmacy (see the CJHP editorial by Raman-Wilms and the CJHP article by Hall et al, July-August 2012). The Pharmacy Experiential Programs of Canada (PEPC) chair, past chair and incoming chairs have submitted a letter to the editor about the CJHP article. Thank you to Ann, Andrea and Angela for their hard work over the summer.

Pharmacists in training – Substantial progress was made on the project over the summer. Presentations about the project were made at the 2012 E-Health Conference and the 2012 International Congress on Nursing Informatics (joint presentations with the Association of Faculties of Medicine of Canada [AFMC] and the Canadian Association of Schools of Nursing [CASN]). Regular project team meetings were initiated. A written competency statement was developed and reviewed via an on-line survey by key stakeholders and organizations. The competency statement will be utilized to identify content areas for the on line educational program. Ongoing work is continuing on the glossary of terms; the environmental scan of information systems being used in pharmacy practice (e.g., electronic health record [HER], electronic medical record [EMR], etc); and the learning management system to be employed for the project. A sample of one educational module for the program is under development. Thanks to Donna Pipa, Marie Rocchi and Nancy Kleiman.

Did You Know?: A Reference at your Fingertips about the Pharmacist Workforce in Canada

The Pharmacist Database (PDB) is a source of timely, quality information for the pharmacist workforce in Canada since 2006. The PDB aims to provide standardized comparative pan-Canadian data and analysis on this third largest healthcare provider group in Canada, which has grown by 19.8% since 2006 to 32,132 pharmacists in 2011. The provincial regulatory authorities and territorial governments are the primary data collectors for the PDB.

Pharmacists in Canada, 2011, released in September 2012, is the sixth annual CIHI publication focusing on the pharmacist workforce in Canada. This publication is a reference document, which can be used to support pharmacist workforce research and planning. The report contains information on the supply, demographics, geographic distribution, education and employment of pharmacists in Canada.

The PDB publications and analysis are used by a wide variety of government and non-governmental organizations to better understand the changing supply and distribution of pharmacists throughout Canada. Accordingly, it contributes to policy formulation and informed decision-making at both the pan-Canadian and provincial/territorial levels.

School of Pharmacy Celebrates Silver Anniversary

Memorial University's School of Pharmacy (SoP) had a special reason to celebrate in 2011-12. This past year was the school's silver anniversary. A number of special events marked the 25-year milestone.

Festivities began last October with the **Silver Anniversary Spirit Week.** A week of activities for students, faculty and staff were held to celebrate the 25th anniversary, including a 'Dress like it's 1986 Day'. The week ended with the School's first Public Pill Drop. This event encouraged members of the public to drop off their expired or unused medications for safe, confidential disposal.

Recurring events such as the Scholarships and Awards Ceremony, White Coat Ceremony and Graduation were also approached with a sense of history and included reflections on the individuals who made a difference in the founding and growth of the SoP.

This year the 4th annual School of Pharmacy golf tournament was also held to coincide with the Silver Anniversary and Reunion 2012 celebrations. On Aug. 9, close to 100 golfers took to the greens at the Bally Haly Country Club in St. John's for a tournament that has come to enjoy strong support from corporate sponsors and the entire pharmacy community. All funds raised go directly to support student scholarships at the School. This year the tournament raised just over \$17,000, adding to a grand total of \$40,000 in the endowed scholarship fund. Sharon Tucker works with the School and is the lead organizer for an event that has grown each year since its inception in 2009.

"When we started in 2009, I had high hopes for success, but the growth we've experienced in the last four years has been incredible," noted Sharon. "The golfers, corporate sponsors, pharmacists and pharmacy community have really gotten behind this tournament. Scholarships are so important for our students, so when you participate in something like this you are really making a difference in the life of a young person. The students are the big winners and for that reason it's a wonderful event."


The Silver Anniversary year was capped off with the publication of the annual report for 2011-12. Titled

The culmination of the Silver Anniversary year coincided with Memorial's first ever all faculties and campuses reunion during the week of Aug. 8-12, 2012. To celebrate both occasions, the SoP hosted two events: a wine and cheese reception for alumni and friends (Aug. 8) and the annual golf tournament (Aug. 9).

The reception on Aug. 8 was held in the professional practice lab at the School and provided a unique opportunity to reconnect with staff, faculty, alumni and friends. In a brief address to the group, Dean Linda Hensman spoke about the importance of the pharmacy community's early support to the founding of the School. "We often talk about our commitment to community, but our history reveals that as a school it is to the community that we owe our existence," she said. "The lobbying effort that started in the 1960's, as well as the early and crucial funding for the School, came from the Newfoundland Pharmaceutical Association and directly from the pharmacists themselves. To them we owe a great debt of gratitude."

Scholarships and Awards Recognize Excellence at the School of Pharmacy

Students, faculty, staff and members of the pharmacy community gathered at the Health Sciences Centre auditorium on Sept. 13 for the annual School of Pharmacy Scholarships and Awards Ceremony.

The event coincides with the culmination of orientation activities at the school and is held to celebrate student achievement while also providing important financial support. Donors that include alumni and friends of the school, members of the pharmacy community, corporations and other organizations funded the 53 awards and scholarships that were presented this year.

In her opening remarks, Dean Linda Hensman talked about the importance of community to the school's success. "These awards and scholarships, the individuals they honour and those responsible for making these gifts a reality, have made a significant and lasting contribution to our school — and by extension have made an investment in the future of our students," she said. "This evening serves as an important reminder that our success is both shared and achieved together. It is our community of alumni, friends and supporters, along with many organizations and sponsors, who extend our positive reach and enable our prosperity."

An award that has been presented on an annual basis since 2006 is the Kristine Cadigan Memorial Award. Open to all pharmacy students, the award recognizes an individual with the qualities that Kristine exhibited – someone who is a well-rounded, dedicated and accomplished student who is willing to help out when needed and is involved in activities both inside and outside the school. "I was surprised and speechless when this award was announced, as there are so many students in the school who are also deserving of such an award," she said. "I am so very grateful to the Cadigan family for their generosity in supporting this award every year and I am truly blessed to have been recognized with it. I know that Kristine was a wonderful person and I am honoured to have received this award in her memory."

The faculty is now offering a joint MBA/BSc in Pharmacy dual degree starting September 2012. The combined program includes 12 months (Fall / Winter / Spring / Summer), during which 11 core courses and three electives are completed. Students enter the program after third-year, and become graduate students for a year. Students then return to the BSc in Pharmacy program to complete the fourth-year, and after that graduate with both degrees at the same time. Up to six Pharmacy students could be admitted in any given year.

UNIVERSITY OF BRITISH COLUMBIA

UBC opens new \$133M Pharmaceutical Sciences Building

On September 18, 2012, the University of British Columbia (UBC) officially opened the new Faculty of Pharmaceutical Sciences Building, a state-of-the-art learning and research facility that will enable UBC to graduate 224 new pharmacists per year by 2015 – a 47 per cent increase – and more than double the research space for drug discovery and health care innovation. The \$133-million, 246,000-square-foot building also supports the expansion of Masters, Doctoral, and Doctor of Pharmacy programs, and offers a new home to several other research organizations, including the Centre for Drug Research and Development (CDRD).

Professor and Dean Emeritus Dr. John McNeill of the Faculty of Pharmaceutical is the recipient of an Honourary Degree from the Faculty of Pharmaceutical Sciences and Biologics at Université Montpellier 1 (UM1).

Faculty Celebrates Research on Grouse Mountain

In addition to being the Director of the Faculty's Division of Pharmacy Practice, Dr. Sproule is a Pharmacy Clinician Scientist/Advanced Practice Pharmacist at the Centre for Addiction & Mental Health. Dr. Sproule's primary focus is clinical research in the area of prescription drug abuse.

Effective May 1, 2013, Dr. Brian Shoichet will join the Leslie Dan Faculty of Pharmacy as a tenured Professor. Dr. Shoichet is an internationally recognized leader in combining computational simulation and experimental techniques to develop new ligands that complement protein structures. Using these techniques, he is also able to develop new targets for existing chemical compounds and new ligands for accessible protein targets.

primary research interests are patients' use of complementary/alternative medicine, the safety and efficacy of natural health products, and complementary/alternative medicine regulation and policy issues.

Dr. Stephane Angers was promoted to Associate Professor with tenure. Dr. Angers is the Canada Research Chair in Functional Architecture of Signal Transduction Complexes at the Faculty. Combining integrative biochemistry, molecular biology and cellular biology approaches with new tools in mass spectrometry and proteomics, Dr. Angers' research program seeks to characterize the function of novel proteins within signal transduction complexes.

Dr. Muhammad Mamdani has been promoted to Full Professor, Status Only. Dr. Mamdani's research focuses on drug safety, effectiveness, and policy. His work for the Ontario Drug Policy Research Network is focused on providing research findings relevant to decision-makers in a rapid manner and brings together leading drug research experts at five medical schools across Ontario and key decision-makers at the provincial government level. His work with the Canadian Drug Safety and Effectiveness Research Network brings together researchers from four different provinces and regulators from Health Canada to conduct and interpret pharmacoepidemiological research.

In this role, Dr. Halapy will leverage his experience as a Clinical Pharmacy Specialist at St. Michael's Hospital, where he specializes in the development of the pharmacist's role in diabetes management.

Grants

The Canadian Institutes of Health Research (CIHR) awarded Dr. Lisa McCarthy (and Co-Investigators Dr. Thomas Brown and Dr. Natalie Crown) a one-year CIHR Knowledge Synthesis Grant for her project "A Scoping Review of Medication Reconciliation Initiatives in Ambulatory Care."

The Ontario Ministry of Health and Long-Term Care has invested in a four-year multidisciplinary study of Dr. Zubin Austin's, (Associate Professor and Ontario College of Pharmacists Research Professor in Pharmacy Practice), entitled "How do practice site interventions support integration of internationally educated health professionals (IEHPs) in the Canadian workplace?"

The Canadian Association for AIDS Research (CANFAR) recently awarded funding for Dr. Reina Bendayan's two-year project entitled "Role of Drug Transporters in Antiretroviral Drug Absorption and Drug-Drug Interactions in Intestinal Tissue."

The CIHR awarded Dr. Stephane Angers a five-year grant for his project "Wnt signalling circuitries in development and cancer." During development, Wnt proteins control cell proliferation, cell differentiation, cell migration and stem cell renewal, while aberrant Wnt signalling causes human diseases including cancers. Dr. Angers' lab has identified several new proteins important to these processes during development and in cancer cells.

The CIHR awarded Dr. Murray Krahn, Professor and F. Norman Hughes Chair in Pharmacoeconomics, a grant to develop a disease-specific utility instrument for bladder cancer health-related quality of life.

Associate Professor Jillian Köhler was recently awarded a CIHR Operating Grant for "Evaluating Governance, Accountability and Transparency in Brazil's noct Pharmaceutical System." This three-year project will see Dr. Köhler identify the laws, regulations and

policies present in Brazil to improve access to essential medicines, study how they were implemented, and determine if they have helped to promote good governance, accountability and transparency.

Assistant Professor Carolyn Cummins received a CIHR New Investigator Salary Award to support early career research in the field of anti-inflammatory drugs and diabetes.

The Natural Sciences and Engineering Research Council (NSERC) recently invested in several research programs at the Leslie Dan Faculty of Pharmacy, awarding three five-year Discovery Grants to Dr. Tigran Chalikian, Dr. David Hampson, and Dr. Jeffrey Henderson.

- Dr. David Hampson for "The calcium-sensing receptor and integrins."
- Dr. Jeffrey Henderson for "Analysis of FADDdependent regulation of programmed cell death."

Dr. Jeffrey Henderson received funding from the Heart and Stroke Foundation for a three-year Grant-in-Aid project entitled "Regulatory interaction of apoptotic/necroptotic PCD pathways in vivo and their functional effect on animal stroke models."

Assistant Professor Dr. Marisa Battistella has received an Allied Health Research Grant from the Kidney Foundation of Canada for "Optimized Dosing of Cefazolin in Patients on Nocturnal Home Hemodialysis," a one-year project that focuses on ensuring the efficacy of antibiotic drugs commonly prescribed to hemodialysis patients to fight infection is not compromised by newer dialysis modalities such as nocturnal home hemodialysis.

With the goal of effecting positive change for the pharmacy profession, the student-run organization SOAPE (Students for Optimizing and Advocating Pharmacy Endeavours) had a very busy and productive 2011-2012 academic year.

'Safe Meds for Seniors' provided students with an opportunity to conduct medication safety seminars for

seniors in the community. Funded by the Ontario Ministry of Health and Long-Term Care and the Ontario Pharmacists' Association, this project allowed students help seniors better understand medication risks and side effects, storage and disposal tips, overthe-counter medications and compliance aids through a series of seminars delivered in community pharmacies.
