
The Faculty of Pharmacy finally moves into the new Jean Coutu Building

What a feat for the project managers! Not only did they respect the construction budget, they met the challenge of a mere 25-month schedule. That's barely more than two years from plans being drawn up to project delivery. Boasting rights for this model construction site go to the entire team responsible for making last March 11 the date the Jean Coutu Building could welcome its first occupants.


With its comfortable, light-filled 42,000 square feet of floor space, the new building allows the Faculty of Pharmacy to accept more undergraduate students and thereby meet the growing demand for pharmacists. Last fall's entry cohort was 170 students. In September 2005, 200 new students will join the Faculty. By providing upto-date research facilities, the building also provides a highly conducive environment for professors, researchers and master's, doctoral and post-doctoral students. Inviting and functional areas are also available for continuing education activities for pharmacists.

It goes without saying that it would have been difficult to carry out such a project without the generous support of the Faculty of Pharmacy's alumni and partners – chief among them, Mr. Jean Coutu. In addition to expressing his gratitude and paying tribute to his alma mater in this way, Mr. Coutu wanted to tangibly support the Faculty of Pharmacy's growth and development. His personal contribution of \$12.5 million is the most generous personal donation to a francophone university in the history of Québec. In recognition of this important donation, the new Faculty building bears his name and the adjacent Immunology and Cancer Research Institute will be named the Marcelle Coutu Building.

Morris Goodman's support also marks a huge step in philanthropy. A 1953 graduate of the Faculty of Pharmacy, and 21 years later still the youngest graduate in the Faculty's history, the pharmacist and Chairman of the Board of Directors of Pharmascience made a \$3 million contribution. His donation was used to complete the Agora. Located between the Marcelle and Jean Coutu Buildings, the Agora is an open gathering place surrounded by green space where students will eat, relax, study and even enjoy access to the Internet.



Other partners support the Faculty in concrete ways as well. Such is the case of Apotex Group, which two years ago donated \$3 million to support and develop the Clinical Associates Program. To show its thanks, the Faculty named the training room dedicated to the program, the Apotex Room. Located just behind the Agora, the room features all the latest teaching equipment.



Moving forward on the new entry-level Pharm.D. and B.P.S. programs

The Faculty is still furthering its efforts in the approval process for its future programs. Good news on the new entry-level Pharm.D.: after presenting and obtaining the endorsement of faculty authorities, professional associations and the Québec Order of Pharmacists, it is now up to the conference of rectors and principals of Québec universities (known by its acronym CREPUQ) to evaluate the file. Let's remember that the Faculty hopes to offer this new program starting in the fall of 2006.

As for the baccalaureate in pharmaceutical sciences (B.P.S.), the program content has been presented and discussed with faculty authorities and experts in the pharmaceutical field. The resulting feedback has made it possible to round out the program structure. The next internal presentations should be held this spring. The Faculty hopes to submit the file to CREPUQ in early May.

New University-based Drug Research group: GRUM

In the past months, the Faculty has worked intensively to set up a large, university-based Research Group dedicated to research on medications known by its acronym GRUM, for Groupe de recherche universitaire sur le médicament.

The GRUM would have a mission to develop and support research, training and technological transfer pertaining to the discovery, development and evaluation of pharmaceutical entities. It is worth noting that a high portion of its activities would be devoted to training and technological transfer.

The new group would bring together representatives of three faculties (pharmacy, medicine, arts and science), with no less than forty researchers in addition to three hundred graduate students.

An application for a grant from the Québec Health Research Fund, the Fonds de recherche en santé du Québec (FRSQ), was completed in the Fall and was very well received by the agency. A final answer is expected in April 2005. The annual budget for the GRUM is \$700,000. Funding will be ensured by a University commitment of \$145,000 per year and a commitment by each of the three founder Faculties of \$40,000 per year, with the FRSQ bridging the gap.

The would-be director of the GRUM is Dr. Michel Bouvier of the Faculty of Medicine, with Dr. Pierre Moreau of the Faculty of Pharmacy acting as a codirector.

The annual general meeting of the Faculty of Pharmacy was held on January 28th. This event gives the Faculty an opportunity to present a summary of its achievements during the previous year to the staff and to outside partners. An important license agreement has been made between North Atlantic Biopharma Inc. (NABPI) and Guangzeng Pharmaceutical Group of Guangdong, China, to bring a seal oil-based pharmaceutical product to market in China. Drs. Hu Liu, Lili Wang and Taki Kara from the School of Pharmacy, and Dr. Philip Davis from the Department of Biochemistry, jointly founded North Atlantic Biopharma Inc. (NABPI) in 2001. The company develops pharmaceuticals derived from marine biological materials from the North Atlantic Ocean. The marquee pharmaceutical product being developed is a unique seal oil-based lipid emulsion used in feeding patients who have difficulty digesting essential nutrients orally such as traumatic and post-surgery patients. While NABPI is conducting some of the pre-clinical studies on MUN campus, the Chinese company is aimed to invest about \$8-10 million to complete tests and set up manufacturing

facilities in China. It is estimated that the development will take three to five years before it reaches the market, which is estimated at \$160 million per year in China. Announcement of this license agreement was made by Dr. Axel Meisen (president of Memorial University), Kathy Dunderdale (Minister of Innovation, Trade and Rural Development, Government of Newfoundland and Labrador), Ken Martin (director of Business Programs for the Atlantic Canada Opportunities Agency), and David Rideout (Atlantic and Nunavut director of the National Research Council's Industrial Research Assistance Program). It was also reported in The Telegram, Saturday March 12, 2005 and on the NTV evening news.

The Research Centre for Fisheries Byproduct, with stakeholders **Drs. Daneshtalab** and Shahidi from Memorial University, two stakeholders from Dalhousie University, one stakeholder from McGill University and one from St. Francis Xavier University, is off the ground. Dr. Daneshtalab will have a biological test facility (including lab and equipment) which will be mainly used for antimicrobial work.

Presentations:

Dr. Mohsen Daneshtalab has two abstracts accepted for podium and poster presentations in the 20th International Congress of Heterocyclic Chemistry (20-ICHC), which will be held in Palermo, Italy July 31 to August 05, 2005. The one for podium presentation covers the design and synthesis of peptidomimetic analogues of Echinocandins, and the poster presentation covers the design, synthesis, and biological evaluation of novel quinolones with anti-cancer activities. He will also give a short presentation about St. John's and MUN and the potential of our city/university to hold the 2009, 22-ICHC meeting in St. John's. Dr. Daneshtalab noted this is a good opportunity to put MUN on the global scientific map.

Dr. Gerry Mugford has an abstract accepted as a short oral presentation at the 93rd Annual CPhA conference in Quebec City, May 23-31, 2005. The title of his abstract is "The Truer Picture of the Continuing Education Preferences of Newfoundland and Labrador Pharmacists: Can we apply what we learned to managing diseases such as HIV?"

Dr. Rebecca Law has an abstract accepted as an oral presentation at the "IPE2005: Interprofessional Education: Grounding Action in Theory" conference in Toronto, May 26-27, 2005. The title of her abstract is "An Interprofessional HIV/AIDS Teaching Module for Pharmacy, Nursing, Medicine and Social Work Students". Other faculty involved in the research are Drs. Sandra MacDonald, **Gerry Mugford**, Vern Curran, Gale Burford, and Ian Bowmer.

Dr. Debbie Kelly was invited to make a presentation to the Provincial Ministerial Advisory Committee on Seniors regarding the findings of her research study, which profiled medication use across the province and estimated the prevalence of inappropriate medication use among seniors. The presentation took place on March 17th and was entitled "Medication Use Among Seniors: Benchmarks and Opportunities for Improvement".

Dr. Rebecca Law led an Oriental exercise break and was a member of the Planning Committee for a conference titled: *Weaving a Warm Tapestry – Nurturing, Caring and Thriving in a Pluralistic Society,* held on March 5, 2005 in St. John's. The conference highlighted the diversity of cultures in Newfoundland and Labrador and presented issues relating to immigration, international adoption and human rights.

The event was sponsored by the Office of Professional Development, Memorial University Faculty of Medicine. There will be future annual conferences dealing with issues relating to cultural sensitivity.

Health disciplines tackle a case study in pain treatment and management

When it comes to promoting interdisciplinary healthcare teams, the University of Toronto's health sciences faculties are way ahead of Ontario's Ministry of Health and Long-Term Care (MOH). For a week each year, second- and third-year students from nursing. pharmacy, dentistry, medicine occupational and physical therapy meet to tackle a case study in pain treatment and management. This year's event, chaired by Judi Hunter of Physical Therapy, brought 754 students and 83 volunteer facilitators together to determine how to treat "Sarah," a fictional woman suffering from pain as the result of a car accident.For three days in mid-March, the students attended lectures about pain treatment and met in teams to create a treatment plan. Facilitators guided the

conversation, urging them to consider issues they might have overlooked. On the final day, they shared their ideas with classmates and faculty. A number of the teams offered plans that included counselling, medication, ergonomics and exercise, each a piece of the puzzle that might be ignored without collaboration.

Watt-Watson it's important said interdisciplinary opportunities at the undergraduate level. "If we don't get to people early in their student careers, their ideas about their colleagues and their approaches to pain have hardened," she said. "This brings all students together." Jake McCracken, a pharmacy student, said he valued the interaction with students from other faculties more than the pain curriculum itself. "In pharmacy, we tend to focus on drugs, but here, we get to see how others approach the problem and how our decisions about medication can affect people from a non-pharmacist's perspective," he said. "I think we should do more of this. It helps prevent the traditional turf wars and teaches us to work together, rather than step on each other's toes."

TAKING NOTE

CPHA REPORT



CPhA's Board of Directors met February 25-26, 2005 in Ottawa. This newsletter will report on the meeting and recent CPhA activities.

Financial Update

At its February meeting, the Board reviews the previous year's financial statements and approves the budget for the year ahead. Financial results for 2004 showed a year end surplus close to budget. A small surplus is budgeted again in 2005, most of which will be allocated to further the development of CPhA's electronic publication capabilities.

Over the past several decades, CPS revenue has enabled CPhA to provide leadership to the profession and to carry out countless initiatives in government advocacy, pharmacy practice research and in the provision of resources and tools for pharmacists. Careful stewardship of this CPhA resource is an important role of the Board, both for the future of CPhA and Canadian pharmacy. Although print sales of CPS have not begun to decline, it is predicted that they will fall over the next 1 to 3 years as confidence grows in the e-CPS and with broader Internet connectivity. For this reason, the economic sustainability of CPhA's electronic products has become a priority. Business consultants have been hired to provide expert advice to staff and the Board. A comprehensive report to include all CPhA's electronic products will be presented to the Board at its next meeting.

e-Therapeutics

The first release of e-Therapeutics is complete and information learned during this pilot will enhance the

development of release two scheduled for roll-out July 2005. e-Therapeutics is CPhA's project with Health Canada to build a suite of electronic tools to provide point-of-care access to current, evidence-based Canadian drug and therapeutic information for primary health care practitioners.

Government Advocacy

With the onset of the new year, CPhA staff and volunteers have engaged in a major round of government meetings. These have included meetings with Health Minister Ujjal Dosanjih, the new Deputy Minister of Health, the Chief Public Health Officer and senior policy advisors from the office of the Minister of Trade. Some of the issues discussed were the National Pharmaceutical Strategy, recommendations around the establishment of a National Medication Management Centre, cross-border drug trade and pharmacists' roles in ensuring public health.

Blueprint for Pharmacy

Changes in the pharmacy profession are essential to achieving health care reforms, particularly with enhanced roles for pharmacists in primary health care. Although substantial resources have been committed by governments to health care renewal, and various projects and programs are now underway to assist in moving the profession forward, the profession is lacking an overall high-level plan to guide and coordinate action over the next 5 to 10 years.

In recognition of this, CPhA proposes the development of a blueprint for the pharmacy profession, to ensure that pharmacy is "fit for purpose" for the health care system of the future. The plan would identify actions needed to achieve this goal. The first stage would involve work by a small group of pharmacy leaders. This will then be validated by a larger stakeholder group, including the CPhA Board, before being released to other stakeholders. Work plans are being developed and funding for this initiative is being sought.

Committee Reports

During the meeting, the Board received reports from several committees. The New Practitioners Advisory Committee is providing advice to staff on attracting new pharmacists as members and is planning events for new practitioners at the 2005 conference in Québec City. As well, the Centennial Committee is gearing up with plans to celebrate CPhA's 100th anniversary in 2007. Be sure to visit the Centennial Committee at its exhibit booth at this year's conference.

A Board Task Force on Committees presented its recommendations to engage members in productive and meaningful committee work. The Task Force will work with staff to flesh out the recommendations for implementation.

CPJ

This spring *CPJ* is taking an important step of its renewal since being brought back inhouse to *CPhA* in 2002. A new Editorial Board, chaired by Ross Tsuyuki,

one of Canada's pre-eminent pharmacist researchers, was appointed in 2004, and along with senior management agreed that *CPJ* needs greater focus and commitment to excellence. Readers will see the first phase of the renewal in the June 2005 issue with the launch of a new name, *Canadian Pharmacists Journal/Revue des pharmaciens du Canada*, a new design, and a change in the content mix.

Home Care

CPhA has recently completed a project, funded by Health Canada's Population Health Fund, to study the role and duties of home support workers, develop training programs and identify specific pharmacists' services to support home care workers in optimizing medications use in seniors receiving home care. The project's overall aim was to reduce medication-related illness in the independent elderly receiving minimal assistance from a family (informal) caregiver. In the first phase barriers and facilitators to involving home support workers and pharmacists in assisting seniors with medication management were identified, while the second phase entailed developing a training program and tools, in both languages, to assist home support workers and seniors with medication management.

As part of the project, a screening tool for actual and potential medication problems for use by home support workers, a resource guide for home support workers and seniors, and a medication training program/workshop for home support workers, were developed and are available from CPhA.
