- Accreditation Standards for the First Professional Degree in Pharmacy Programs
- ('Guidelines' removed)
- · Maximum length of accreditation 8 years
- Met, Partially Met and Not Met will continue.
  The standard and all criterion must be met or the standard will be partially met or not met





### **Approved**

- Identified 14/35 Critical Standards considered deal breakers.
  Assigned a weight of 3. The number of them Met or Not Met should factor into the length of accreditation Award.
- Other standards have been assigned weights of 2 or 1.
  Weight for each Standard is now shown in the Accreditation Standards document.
- Each criterion under a standard is assigned a weighting factor which totals the weight of that Standard

#### **Approved**

- Standard 32 deleted Co-op programs
- Now included as a note under Section IV —Academic Program — if practice experiences are structured under co-op arrangements, the Faculty must ensure that the co-op site and preceptor selection criteria, program-defined educational outcomes, length of practice experiences, student assessment are established and verified in a manner equivalent to traditional experiential placements.

- · Directions included in with the Standards
- Use of tables recommended when appropriate
- On completion of the self-study, an executive summary should be prepared summarizing the strengths and weaknesses under each Section

## **Self-Study**

COMPREHENSIVE INTERNAL REVIEW REPORT
 Generally, in the comprehensive internal review report and for each

standard, facts and findings (ideally presented in table format) should be analyzed to determine strengths and areas of improvement. It is recommended that an average page limit of 3-4 pages per standard be used. Appropriate referencing to supportive information (data, procedures and policy) should be provided with the text, and the supporting documents attached as appendices.

Areas of improvement – what are the plans in moving forward? Should not be an embarrassment to show there are areas that could be improved.

## **Self-Study**

 While a Faculty may wish to informally judge its compliance (i.e. 'met', 'not met', 'partially met') with CCAPP standards during its internal review process, the final documents submitted to CCAPP site visit evaluation team members should not include the Faculty's opinion of its compliance with the Standards.

- Listing of Faculty will also require their expertise related to the curriculum
